Conditions of Sale

1. Trees must be for conservation purposes.
2. No plant purchased from the Laramie County Conservation District may be resold as a living plant.
3. Bareroot stock is available in multiples of 25 per species only. (Bundles)
4. Large Tube stock is available in multiples of 30 per species only. (Boxes)
5. Payment must accompany order.
6. Substitutions—if trees ordered are sold out, a full refund will be provided unless a substitution is requested and agreed upon.
7. **NO WARRANTY, EXPRESSED, OR IMPLIED, IS MADE BY THE CONSERVATION DISTRICT OF THE SEEDLING STOCK.**

Application & Planting Services

- The District provides both fabric mulch application and tree planting services for trees and/or fabric purchased from the District only.
- In order to be placed on the list for these services, a paid Tree Order Form must first be received.
- Plantings will receive confirmation of your order. Planting/fabric application fees are billed upon completion.
- Installation of the fabric and trees is also contingent on a District approved windbreak design. (For an appointment, please call 772-2600.)
- If homeowner is installing fabric or planting trees, One Call of Wyoming (1-800-849-2476 or 811) is required at least 2 days prior to doing the work.

Fabric mulch installation fees:

- Up to 1,500 ft. – flat fee of \$150 plus \$.40/linear foot for fabric mulch
- Over 1,500 ft. - \$.50/linear foot

Tree Planting fees:

- 1-250 trees – flat fee of \$125 *
 - 251+ trees - \$.50/tree*
- *Trees are purchased separately below*
